## Message from the FIDE Representative: FIDE Report

76<sup>th</sup> FIDE Congress  
Dresden, Germany  
August 17-24, 2005

The main news for Canada was that Hal Bond was awarded the titles of International Arbiter and International Organizer; and that Roman Pelts was awarded the title of FIDE Trainer. Congratulations to both men.

The Commonwealth Chess Association has been revitalized, with Grandmaster Nigel Short becoming the new Secretary General.

There were many serious complaints about the World Youth Championships held in Belfort France, in 2005. Mr. Touze, the organizer, will not have the right to organize any FIDE event for 5 years.

It was decided to lower the rating floor to 1400 (on January 1, 2006) in order to have fewer unrated players in the Olympiad.

Many illegal things seem to be occurring. People reduce their rating points to win low category tournaments. Grandmasters lose games in exchange for money, so weak players can obtain titles. Therefore the titles committee is looking carefully at suspicious results, and is trying to tighten the regulations.

## Message from the Treasurer:

The CFC Office is currently located in a business condominium in Ottawa. The condominium as

a whole is a very poor state due needed repairs not being done by the previous property management group. Almost all the roofs must be repaired within one year, some walls are no longer waterproof and a sidewalk is crumbling. The total cost of all the repairs has been estimated to be over one million dollars.

A condominium is composed of parts owned by different owners, like us, and of commons areas that are used by every owner. Each year, a management group is elected. The group is empowered to charge all owners for the commons parts and for repairs. Under Ontario law, the group is required to maintain a sufficient reserve fund to cover urgent repairs to the building. Regretably insufficient reserve funds were put aside by the former management to cover the required repairs

We have been accessed \$12,667.29 which needs to be paid over the next 9 months in three equal instalments. The first instalment will be in this fiscal year and the last two will be in the next year. Those repairs will increase the value of the building. We have the money in the bank but it will hurt us to pay it. From an accounting point of view, the expense will be amortized over a period of 20 years, nevertheless, it needs to be paid now. This unexpected expense definitely hurts our budget but it is not catastrophic and we are able to pay it

Even more annoying then the money owed is the fact that we can hardly move out of Ottawa (as some Governors have suggested) with a damaged building whose fair market value (for selling or renting) is greatly diminished until repaired.

**Message from the Secretary:**

I have enclosed a newsletter (see Appendix 1) from the Commonwealth Chess Association. This was sent to me as an attachment rather than a website link. I would like to get a consensus of the Governors as to whether they would prefer getting more of this sort of thing or not. My personal preference would be to freely include URLs to info of this type rather than to include such documents in the GL proper although I strongly feel that part of my mandate is to make such material available to Governors.

There is an important motion on Quebec affiliation (see 2006-08) which the President has ruled (a) that it should be dealt with by the Governors rather than the Executive and (b) being a quasi-constitutional matter voting on this motion will proceed by Handbook rule 1.15.

The reason this GL has been delayed is that it has taken longer than expected to get financial results as well as a message from the President who was offline due to computer problems. The GL has essentially been at the “95% complete” stage since before New Years’.

There are three amendments to 2006-06 which you may vote yes to all, no to all or a mix of the two. Anyone wanting to mix their votes or make them conditional on the outcome of the others, I will do my best to translate your wishes. It is intended to vote the amendments in this GL and the amended (or not) motion in GL#6. Comments on either side are more than welcome.

I have had several inquiries on the lateness of this GL. All I can say is that I committed to monthly GLs on the basis that reports would be received by the needed cut-off dates which were specified at the beginning of the year. While we’re considerably past that date for GL#5, I still hold to that commitment.

## **MOTIONS FOR FINAL VOTE:**

**Motion 2006-06 (Moved Alex Lambruschini, Seconded Mark Dutton):**

Whereas no regulations exist to address unsportsmanlike and unethical behavior by members, or defend the good standing of CFC members from such behavior;

Be it resolved that the CFC create an Ethics Committee to address unsportsmanlike and unethical behavior by members. Members can appeal to the Ethics Committee when their good standing has been impugned or to draw attention to unethical behavior on the part of CFC members. The Ethics Committee shall operate as follows:

Composition -

- The EC will be chaired by a member of the CFC Executive, who will appoint two members to the committee from amongst the CFC Executive or Board of Governors.
- The Chair of the EC will be appointed by the President at the AGM.

Responsibility -

- An appeal by a CFC member to the EC is to be made to the Chair.
- The Chair will determine in consultation with the other members of the EC whether the appeal is justified and if so what level of rebuke is called for.
- It is the responsibility of the Chair to ensure an adequate public response is made to defend the good standing of the CFC member when unethical behavior has harmed an individual member. On a public message board, this response need not be more than a generic response to that effect.
- It is the responsibility of the EC to consider the degree to which unethical behavior in question has reflected poorly on the Canadian chess community. The EC must strive to take measures to protect the public integrity of the Canadian chess community.

Authority -

- Depending on the severity of the ethical misconduct of a CFC member, the EC will have judicial authority ranging from the issuing of a written warning to expulsion of the member from the CFC.

### **Motion 2006-06: Ethics Committee**

*Michael Barron:* I support this motion.

*Martin Jaeger:* Could we get a lawyer's opinion on this with a view to knowing if any liability to the organisation can occur and (if so)what if anything we should do about it.

**Chris Mallon: I have three amendments to this motion:**

**Amendment 1:** (Clarified it and made it a bit more fair in the way the EC is selected)

That:

Composition -

- The EC will be chaired by a member of the CFC Executive, who will appoint two members to the committee from amongst the CFC Executive or Board of Governors.
- The Chair of the EC will be appointed by the President at the AGM.

Be changed to:

Composition -

- The EC will be chaired by a member of the CFC Executive, to be appointed by the President during the Incoming AGM.
- The EC will include the CFC Master's Representative
- The EC will include one other respected individual, to be elected at the same time as the other CFC Directors.
- The term of the two members other than the Master's Representative will last until the AGM of the following year.

Quote:

**Amendment 2:** (I replaced "On a public message board, this response need not be more than a generic response to that effect." and made some other minor changes)

That:

Responsibility -

- An appeal by a CFC member to the EC is to be made to the Chair.
- The Chair will determine in consultation with the other members of the EC whether the appeal is justified and if so what level of rebuke is called for.
- It is the responsibility of the Chair to ensure an adequate public response is made to defend the good standing of the CFC member when unethical behavior has harmed an individual member. On a public message board, this response need not be more than a generic response to that effect.
- It is the responsibility of the EC to consider the degree to which unethical behavior in question has reflected poorly on the Canadian chess community. The EC must strive to take measures to protect the public integrity of the Canadian chess community.

Be changed to:

Responsibility -

- An appeal by a CFC member to the EC is to be made directly to the Chair, with a copy sent to the Business Office.
- The Chair will determine in consultation with the other members of the EC, as well as the persons involved, whether the appeal is justified, and if so, what level of rebuke is called for against the offending party.
- It is the responsibility of the Chair to ensure an adequate public response is made to defend the good standing of the CFC member when unethical behavior has harmed an individual member. Official statements from the EC should be posted on the CFC Website and Discussion Forum as well as be included in the Governor's Letter.
- It is the responsibility of the EC to consider the degree to which unethical behavior in question has reflected poorly on the Canadian chess community. The EC must strive to take measures to protect the public integrity of the Canadian chess community.

Quote:

**Amendment 3:** (Listed more specific details)

That:

Authority -

- Depending on the severity of the ethical misconduct of a CFC member, the EC will have judicial authority ranging from the issuing of a written warning to expulsion of the member from the CFC.

Be changed to:

Authority -

- The EC will have the authority to impose penalties, based on the severity of the ethical

misconduct

- Penalties may include written warnings, suspensions ranging from 1 to 12 months, and temporary or permanent expulsion. A suspended player may not play any rated games but still gets all other benefits of being a CFC member.
- The EC may at its discretion choose to offer the choice of a fine (between \$10 and \$500) to a member being given a penalty. (Example: instead of a 6 month suspension, they may pay a \$250 fine). Fines are not an option where expulsion is considered.

**Procedural note: while each amendment must be voted separately what follows is the final text if all three amendments pass. Please note that you are asked to vote each amendment separately with the vote on the main motion (plus whichever amendments are passed) to take place in the next GL.**

**Thus:**

**Amendment 1, Motion 2006-06: Vote Yes, No or Abstain**

**Amendment 2, Motion 2006-06: Vote Yes, No or Abstain**

**Amendment 3, Motion 2006-06: Vote Yes, No or Abstain**

**In the event all three amendments are adopted, in GL#6 we will be voting as follows:**

**CONSOLIDATED MOTION – text in italics as amended by the Mallon amendments**

Whereas no regulations exist to address unsportsmanlike and unethical behavior by members, or defend the good standing of CFC members from such behavior;

Be it resolved that the CFC create an Ethics Committee to address unsportsmanlike and unethical behavior by members. Members can appeal to the Ethics Committee when their good standing has been impugned or to draw attention to unethical behavior on the part of CFC members. The Ethics Committee shall operate as follows:

- The EC will be chaired by a member of the CFC Executive, to be appointed by the President during the Incoming AGM.*
- The EC will include the CFC Master's Representative*

- The term of the two members other than the Master's Representative will last until the AGM of the following year.*

*Responsibility -*

- An appeal by a CFC member to the EC is to be made directly to the Chair, with a copy sent to the Business Office.*
- The Chair will determine in consultation with the other members of the EC, as well as the persons involved, whether the appeal is justified, and if so, what level of rebuke is called for against the offending party.*
- It is the responsibility of the Chair to ensure an adequate public response is made to defend the good standing of the CFC member when unethical behavior has harmed an individual member. Official statements from the EC should be posted on the CFC Website and Discussion Forum as well as be included in the Governor's Letter.*
- It is the responsibility of the EC to consider the degree to which unethical behavior in question has reflected poorly on the Canadian chess community. The EC must strive to take measures to protect the public integrity of the Canadian chess community.*

*Authority -*

- The EC will have the authority to impose penalties, based on the severity of the ethical*

*misconduct*

- *Penalties may include written warnings, suspensions ranging from 1 to 12 months, and temporary or permanent expulsion. A suspended player may not play any rated games but still gets all other benefits of being a CFC member.*
- *The EC may at its discretion choose to offer the choice of a fine (between \$10 and \$500) to a member being given a penalty. (Example: instead of a 6 month suspension, they may pay a \$250 fine). Fines are not an option where expulsion is considered.*

***Special Reminder from the Secretary: All governors should note that the President has declared 2006-06 a constitutional amendment thus requiring a 66 2/3% vote to pass***

**Motion 2006-07 (Moved Joshua Henson / Seconded Lyle Craver)**

**Re: Renewal of CFC Memberships**

1. Players renewing their membership within one month of expiry will have their memberships backdated to show continuous membership
2. Players who renew their membership more than one month but less than three months after expiry shall have the option to backdate their membership to show continuous membership. Players who do not specify shall be renewed at the date of renewal (Note that this may mean missing magazine issues)
3. Players who play in rated events and pay their memberships at the tournament site shall be deemed to have renewed as per 1 and 2 respectively.
4. Players who renew in this way shall receive their magazines as soon as possible after renewal.

**Motion 2006-07: CFC Membership Renewal**

***Michael Barron:*** The CFC membership administration should be as simple as possible. I would suggest sell the membership for calendar year only. And it should be a member's responsibility to maintain a continuous membership. But first we need clearly define which privileges a CFC member has.

**MOTIONS FOR FIRST DISCUSSION:**

**Motion 2006-08: Quebec Affiliation (Moved/Seconded Pierre Dénommée / Bela Kosoian)**

That the CFC recognise the Fédération québécoise des sports échiquier as the new CFC affiliate in the province of Quebec according to the following rules

(a) An ballot will be added into the June or July (whichever is real) issue Chess Canada Échecs sent to Quebec addresses so that every CFC member could vote for the new FQSE executive.

(b) From the date of approval of this motion and until the election, the CFC shall keep the provincial part of every membership sold in the province of Quebec. After the election, the provincial part shall be remitted to the new Association.

(c) a temporary executive with the sole mandate to draft the Constitution and bylaws will be put in place until the election. Because the FQE might want to act against those individuals, non-chess players who cannot be harm by the FQE have been selected.

(d) the temporary executive is also empowered to bid for National Championships, to organise Provincial Qualifiers and to determine the amount of the provincial part of the membership.

**Pierre Dénommée:** See Appendix 2 “**Toward a new CFC affiliate for the province of Quebec**”

**Chris Mallon:** Voting on this motion will proceed by Handbook rule 1.15.

### **General Comments from Governors:**

**Michael Barron:** Thanks to our Executive for keeping their promise to issue Governors’ Letter monthly!

This is important way to communicate. But I would like to support Governor Nikouline: the CFC Governors forum is the most efficient way to discuss the motions and we need to encourage active participation of the Governors. If we could have real discussions on the CFC Governors forum, we would make decisions faster – a motion could be presented for discussion in one GL and for vote in the next GL.

Not less important is to keep track of our motions. If a motion requires changes in the CFC Handbook, such changes should be posted on the CFC website immediately after a motion passed before the next GL.

were voted by the Assembly of Governors and passed during last year.

All of them require changes in the CFC Handbook published on the CFC website, but those changes still were not made. I believe we should incorporate necessary changes in the CFC Handbook published on the CFC website as soon as possible.

For example, the CFC Handbook on the CFC website ([http://www.chess.ca/section\\_3.htm](http://www.chess.ca/section_3.htm)) contains the following regulation:

”375. Tournament Playing Fee: A tournament fee for first time players in CFC events, for foreign players, and for players whose name does not appear on the last Annual List, of \$10.00 may be paid in lieu of CFC membership. The player will then receive a rating, one copy of the magazine, and an invitation to join the CFC. [see Motion 90-9, as amended, GL, September 1990, p.1-12]”

The recent GTCL practice shows that some players misunderstand the concept of the tournament fee. We need some clarification and re-writing of this regulation.

## 3) THE FIDE CONGRESS 2005

This was held in Dresden, Germany in August 2005, and the CCA also held its Annual Meeting then.

There was a good attendance, despite it not being an Olympiad year, and many ideas were thrown around, before, during and after the meeting.

Concern was expressed that the various legal problems in Indian Chess were hampering the progress of the CCA, and so, after discussion, and in accordance with the agenda and the statutes, it was moved that a new post, “Secretary-General”, was to be created. This was agreed, without opposition, and GM Nigel Short of England was then nominated, and elected unanimously.

## 4) COMMONWEALTH CHAMPIONSHIPS 2005/6/7

These have already been decided for the years 2005-6-7, and awarded to India, India and South Africa respectively, as stated in the minutes of the 2004 CCA Meeting in Mallorca, though some problems have arisen.

For 2005, this was awarded to India, but with their various internal problems, and after discussion with their delegate at the CCA meeting, in view on the ongoing situation, it was agreed not to hold them to their agreement for this year, and the event subsequently did not come through.

For 2006, it has already been awarded to India, and they have confirmed their wish to hold it. We await further news, and specific dates. We advise all to check the Indian Chess website, which is [www.indianchess.org](http://www.indianchess.org).

For 2007, this has been awarded to South Africa. They told of some problems, but will report further by the end of the year (2005) with regard to the holding of the event.

We will inform everyone as soon as possible.

## 5) FIDE WORLD CHAMPIONSHIPS

### TOPALOV WINS FIDE TITLE

The FIDE World Championships were recently held in San Luis, Argentina, with the Bulgarian, Veselin Topalov (2782) emerging victorious.

It was a double round robin of 8 players, meaning 14 rounds. The players were: Alexander

Morozevich (2707) and Peter Svidler (2740), of Russia; Peter Leko (2751) and Judit Polgar (2735), Hungary, Vishy Anand (2788), India, Veselin Topalov (2782), Bulgaria, as well as Rustam Kasimdzhanov (2670), Uzbekistan, and Michael Adams (2718), England.

The first six were selected by ratings, while the last two by virtue of their placing in the last FIDE event. Topalov won the event comfortably, and it featured some fighting chess. He started in a blaze of glory, scoring 6.5 from the first 7 games and then cruised home with draws in the second half of the event, fighting off a few dangerous situations, but never being seriously challenged overall.

Topalov finished on 10 points from the 14 games, while second place was shared by Vishy Anand (India) and Peter Svidler (Russia), on 8.5 points each, with Anand taking second on the the-break. The Commonwealth was represented by two players, Vishy Anand of India, and Michael Adams of England, and they had mixed fortunes.

Anand was many people's favourite, but he fell behind early with losses in round 4 to Kasimdzhanov, and round 7 to Morozevich, and several draws, but recovered slightly to finish in joint second place, while Adams on the other hand, had a disastrous start and never recovered, finishing with 5.5 points, ahead of only Judit Polgar, who scored 4.5.

The Australian Nationals will be a closed event, though specially invited overseas players like GM's Murray Chandler and Lubomir Ftacnik (2612) of Slovakia will be participating.

Now, a short flight across the Tasman Sea to NEW ZEALAND we find:

NZCF President FM Bob Smith reports that plans are ongoing for the "Queenstown Chess Classic", which will be held in Queenstown, from 15<sup>th</sup> to 24<sup>th</sup> January 2006.

This will be the most prestigious event, with the biggest prize fund in New Zealand Chess history, and will incorporate the 113<sup>th</sup> New Zealand Championships, as well as the New Zealand Rapid Play and Lightning Championships on the two days after the main event.

It caters to everyone from Grandmasters to novices, and is the brainchild of GM Murray Chandler, who is New Zealand's only Grandmaster, and will be competing.

Other GM's registered by 29<sup>th</sup> October are Australia's Ian Rogers (2556) and Lubomir Ftacnik (2612) of Slovakia, while there are confirmed entries from players rated below 1000!

Queenstown is indisputably one of the most scenically beautiful places in the world ( and even the most die-hard Aussies would agree with this!), so, if you fancy a vacation in a beautiful place, with a chess tournament, then check their website [www.queenstownchess.org](http://www.queenstownchess.org) for more details.

If you enter saying you first heard about it from the Commonwealth Chess newsletter, you may receive a discount! (But then again, you may not!).

As well, the new CCA Secretary General, GM Nigel Short will be on a tour of New Zealand in November, and we hope to record his adventures in the second CCA Newsletter.

Before we head west, lets fly east to Fiji for a few days!

Fiji is also a FIDE country, but what do we know except they come to Olympiads regularly?

Not much!

We now know that the “JR White FIJI National Championships” will be held from 11-13 November 2005, and we hope to learn more of Chess in Fiji in future Commonwealth Newsletters.

Let's face it - which chess player would not love to tell his partner - “Sorry, dear, I have to go to Fiji next week, for a serious chess tournament, so you stay at home and look after the kids!”

Back to New Zealand, and we fasten our seat belts once again, before heading west, to Africa.

## 8) AFRICA

A continent of numerous countries, of whom many are members of FIDE., and many are also members of the Commonwealth.

The most important coming African events are the African Individual Championships, which will be held in Lusaka, Zambia from 3-15 November 2005, while the African Junior Championships will be held in Gaborone, Botswana from 9-22 December 2005.

Both should be very interesting events, throwing up much new talent, hopefully from Commonwealth countries.

Africa has numerous strong players, many of whom are from Commonwealth countries, and we hear from South Africa, courtesy of IA Gunther Van Den Bergh, and the South African Chess Federation's website [www.chessa.co.za](http://www.chessa.co.za) that South Africa is to be represented at the African Individual, by IM Watu Kobese (2403), IM Kenny Solomon (2352), FM Charles de Villiers (2286), Daniel Cawdery (2182), and Donovan Van den Heever (2132).

South Africa will also be holding the Chessa Junior Championships in Port Elizabeth, South Africa, from 4-14 December 2005.

From Botswana, we learn from TD Muza Muskwe, that they are hard at work preparing for the African Juniors event.

As well, we understand that Botswana will send three players to the African Individual Championships in Lusaka, Zambia, in November. They are Ignatius Njobvu (2201) and Moakofi Notta, while the Women's rep is Tuduetsso Sabure (2075) who is the national Ladies champion.

The Botswana National Championships will be held next March /April with the defending champion being Phemelo Khetho (2238) while the players have to go through two qualifying events to reach the finals.

*We have just received the final results from the African Individual Championships, which were won by GM Ahmed Adly (2480) of Egypt, with 7 points from the 9 rounds, while second and third places went to GM Slim Belkhodja (2490) of Tunisia, and FM Aly Frhaty (2306) of Egypt, with 6.5 points.*

*The best placed Commonwealth players were Stanley Chumfwa ((2303) of Zambia, in 4<sup>th</sup> place, also with 6.5 points, and the South African IM Watu Kobese (2403) in 6<sup>th</sup> place with 6 points.*

*Botswana's Ignatius Njobvu (2203) finished in tenth place with 5.5 points, in a field of 35 players.*

*In the Women's section, Botswana's Tuduetso Sabore (2075) finished as champion with 7 points, while South Africa's Denise Frick (1907) and Anzel Laubscher finished third and fourth.*

*We hope to bring a full report on this event in our next Newsletter.*

Now we have travelled through Africa, it is a short hop to the Caribbean, (or at least it would be if there were direct flights, which there are not, so via London again!)

After another 8 hours from London, making 16 hours in all, we arrive in .....

## 9) THE CARIBBEAN

The Bahamas Fall Classic 2005 was held in September- and the joint winners were Elton Joseph and Frank Gibson, who both finished with 3 and a half out of 4.

Joseph is an 18 year old student of College Bahamas, while Gibson is the National champion. They will meet in a 6 round play-off in November 2005 to decide the new National Championships.

Hey, you Bahamians- why do we not see you regularly at Chess Olympiads? They are a great chess experience. Be there!

And now south to the only countries to coincide their Nationals with the CCA's first Newsletter, Barbados and Trinidad!!

FM Delisle Warner (2229) is the new Barbados National Champion after the recently held National Championships.

Warner finished with 10/11, while he might admit to having been fortunate on several occasions, in an event which featured more than the average numbers of blunders! Second place went to the talented youngster Martyn Del Castilho, with 9/11, who is the bright young hope of Barbadian chess. He is still a schoolboy, and gained valuable experience at last year's Olympiad in Mallorca as a reserve, playing a few games, as well as in the side events. Watch out for him in the future!

Third place went to the dynamic but erratic Dr Philip Corbin, on 8/11.

Warner first won the title in 1989, and has always been in the top three, while this year, the 2004 champion, IM Kevin Denny did not defend his title. Denny is the only IM in the English speaking Caribbean, and at 2365, he is still the highest rated player.

In Trinidad, their Nationals also recently finished, and the new champion is FM Ryan Harper.

Harper, who first won the title in 2002, and recently graduated from the University of New Brunswick with a degree in Business Administration, as well as being the first Trinidadian to gain the FM title, finished on 9/11, losing only to the defending champion FM Christo Cave, who started well but faltered in the middle of the event.

Second place went to the very solid Yogendranath Ramsingh, on 7.5 points, though he had chances to win his final round game against Harper, which would have given him the title.

Sharing third place on 7 points was the defending champion, Christo Cave, along with Dr Edison Chang, Sean Perryman and Mario Merritt.

Jamaica held their National Championships early in the year and the talented young FM Warren Elliott (2262) retained his title. The 2006 Men's nationals will be held in January/February 2006, as part of their Olympiad team selection process.  
Their Women's nationals will be held in Nov 2005.

There is plenty of talent in the Caribbean, and the junior players are now getting much more international exposure. It gets harder once you have to work for a living, and air-fares in the Caribbean are not cheap!

From the Caribbean, we now pack our bags again, and go via London yet again, with a total of another 16 hours or so in flight, to.....

## 10) ASIA

Where to start in Asia?

India is the powerhouse in Asia, but their top players and events are well reported, as one can check from their website [www.indianchessfed.org](http://www.indianchessfed.org).

Asia in general has many websites, and we draw our readers attention to the website [www.aseanchess.com](http://www.aseanchess.com) which has links to many Asian Chess Federations, including several Commonwealth ones, such as Singapore and Malaysia.

We hope to include interviews with Chess people in various regions in future issues, and there is an interesting interview with Ignatius Leong in the website [www.intchessasia.com](http://www.intchessasia.com) which we draw to your attention.

Ignatius is a truly dedicated chess man, President of the Singapore Chess Federation; an International Arbiter, Chief Arbiter at the Mallorca Olympiad in 2004, and a Vice President of FIDE, etc etc, while not being isolated from controversy in his career!

The interview is very interesting. He is resigning as President of the Singapore Chess Federation this year.

However, we start elsewhere, in Bangladesh...

They start their chess league on 12<sup>th</sup> Nov, until 27<sup>th</sup> Nov 2005, and the defending champions are the "Leonine Chess Club".

In the past they have had guest players, such as GM's Yuri Shulman (Belarus); Raussis (Latvia); Dimitri Kumarov ((Ukraine), Alexie Barsov ((UZB) and others, just as the major leagues in Europe, such as Germany France and England routinely have overseas players.

In a country like Bangladesh, the appearance of these strong overseas players can only help the talented youngsters learn. In Malaysia, the Malaysian Open 2005 was won by a 16 year old Chinese lad named Wang Hao , who scored 10/11, ahead of GM Antonio from the Philippines on 8/11, while the highest placed Commonwealth player was the Australian GM Ian Rogers, who finished third on 7.5/11 in a field which included 12 GM's, and 10 IM's.

Rogers also won the 5<sup>th</sup> Bangkok Open with 7.5/9, ahead of GM Eugenio Torre on the tie-break.

## 11) OTHER NEWS

In other news, we draw attention to the Gibraltar Open, to be held in Gibraltar from 24<sup>th</sup> January until 2<sup>nd</sup> February 2006, run by IA Stewart Reuben. ## **Appendix 2:** **Toward a new CFC affiliate for the province of Quebec**

### *Presentation of the problem*

Article 360.2 of section 3 of the CFC handbook present the problem quite neatly: the FQE is not participating to the payment of the international expenses of the CFC. Contrary to what has been sometime claimed on the FQE side, this issue has nothing to do with neither Sovereignty nor federal-provincial relationships. The primary problem was and remain that for each FQE membership sold, nothing ( 0\$ ) is sent to the CFC. Consequently, the FQE does not contribute a single cent toward the payment of the CFC most costly expenses: the cost of sending our national's teams and individual Canadian Champions to the World Championships and the Olympiads. For the current year alone, such expenses are estimated to be around 65 000\$.

### *Direct consequences*

The most immediate consequences are monetary: more then 30 000\$ per year is lost by the CFC. In the past years, the CFC has sometime been unable to send a Women team to the Olympiad and has never been able to send a team to the Youth's Olympiad even though we would have strong winning chances when both Mark Bluvstein and Thomas Roussel-Roozmon could have played. Our participation in the Pan-American has not been constant. *In general, our talented players have not been able to take part in all international competitions for which they have qualified.* Furthermore, as it as been stated in the report from our former FIDE delegate, Canada is unable to organise is fair share of international events such as the Continental Championship or the Pan-American.

### *Indirect Consequences*

CFC members in Quebec can neither choose their Governors nor the leadership of their Provincial Affiliate. Since CFC members have no right within CFC, Quebec's CFC members have no say in the running of the Federation. This sad situation explains in part the extreme difficulty that we are facing when trying to sell memberships.

CFC members in Quebec are dissatisfied with the lack of service in French, especially the lack of adequate translation of critical pieces or regulation such as the Laws of Chess and the CYCC regulations.

Furthermore, the actual lack of CFC members in Quebec makes it impossible to run a weekend Swiss in Montreal without running the risk of a heavy deficit<sup>1</sup> unless members from other provinces participate. Only the Gatineau region runs regular CFC events in which members of the OCA can easily participate by crossing a bridge over the Ottawa River.

The Montreal Chess League actions are impeded by the lack of an affiliated Provincial Association because some financial support request forms encompassed questions on affiliations and the lack of a recognized Provincial Affiliate is detrimental to the League fundraising effort.

Chess cannot be recognised as a sport by the Quebec Government without an affiliated Provincial Association<sup>2</sup>. *The FQE does not want to try to be recognised as a sport federation because it would then be compelled to affiliate with the CFC.*

Last and not least, the lack of a Quebec Affiliate is most likely detrimental to both the image and the fundraising abilities of the CFC. As a national federation, the CFC should have affiliates in all the ten provinces.

## Why creating a new affiliate in 2006

- To foster the growth of the CFC in Quebec.
- To organise the QYCC, the Quebec Junior and the Quebec Championship<sup>3</sup>.
- To enable volunteer to get involved into a Provincial Association.
- To provide adequate service in the French<sup>4</sup> to all Canadians<sup>5</sup>.
- The FQE has unveiled its strategic planning, a 24 pages document which not only fails to mention any will to reaffiliate, but also fails to include the words *Canada* and *Canadian*. In fact, the reader of this document will get no clue about the existence of the CFC.

More importantly, there is a possibility to get recognized by the Quebec Government as a sport. This would have no impact on the FQE that would still be recognized as a recreation<sup>6</sup>. The recognition is automatic if an organization meets the relevant criteria labelled A to G which are<sup>7</sup>

- A. Being incorporated as a non-profit corporation for at least one year and that the majority of the members do not live out of salaries obtained because of their activities inside the provincial association.
- B. To have existed for at least two years and to have realized projects in favour of our members.
- C. To pursue a goal of public interest in sport.
- D. Be a public and democratic organism open to all members or to all the delegates of associations interested in Chess.
- E. Insure the security of chess players and spectators
- F. Receive the mandate from its members to perform the duties of a provincial sport federation and to have CFC Governors representing Quebec within the CFC.
- G. *Be affiliate to the Federation responsible for Chess in Canada which is the CFC. The CFC must be recognized by the Canadian Olympic Committee and affiliated to an international organization (FIDE) recognized by the IOC (this has already been done).*

Of all those points, only C) could be used by the Government to refuse Chess as a sport by stating either that Chess is not a sport or that there is no public interest in Chess. With Patrick McDonald paper on the benefits of Chess in education, it is impossible to claim that there is no public interest and indeed, the provincial education ministry already recognized the usefulness of Chess in school. The Liberal Government of Quebec has fused the ministries of Education, Sports and Recreations. Since the education minister and the sports minister is the same person, it would be quite unconceivable that he support Chess as the minister of education and that he would be against Chess as the sports minister. This advantageous situation will not last forever because there are 2 to 3 years left before the next election and if the Liberals are not re-elected, the two ministries could be given to two different persons.

## Planning

We have carefully planned the remaining steps required to create an Affiliate in the Province of Quebec. The new association will remain unincorporated during its first year for practical reasons: under Quebec's Laws, it is easier to modify the number of governors, the objects, the Constitution and the by-laws when the association is not incorporated because any amendment method written in the Constitution is deemed

appropriate, whereas incorporated associations are often forced to call a special AGM<sup>8</sup> far every minute change. Furthermore, the Quebec Government permit one year of unincorporated life to all sport federations. Remaining unincorporated for more then one year is not advisable and would hurt our chances to be recognised as a sport because we need at least one year of existence as an incorporated non-profit and at least two years of total lifespan.

We did think about asking the MCL to simply change its name and take over as the Provincial Affiliate but this would be inconvenient to them because it would require a constitutional amendment for the League to operate outside of the Montreal Island. The provincial government could veto<sup>9</sup> this change and even if it is approved, the MCL would be automatically expelled<sup>10</sup> from the Montreal Island Sports and Recreation Council where it has full voting rights.

The process of writing the Constitution and by-laws of the new Affiliate has begun. According to the standard procedure in Quebec<sup>11</sup>, the founders are ex-officio the first governors of the newly created association. Their duties consist of writing the Constitution and by-laws of the association and to call the first AGM. The first AGM consist solely of the founders who are ex-officio members. During this AGM, the Constitution and by-laws are officially adopted and the founders elect themselves as governor. Usually, the rules will enable new members to join<sup>12</sup>. A recruiting phase follow and at most one year later, the first real AGM with the non-founding members is called. Because the CFC has already members in Quebec, we could proceed with the first real AGM much faster.

### *Conclusion*

There has never been a better moment then now to form a new Quebec Provincial Affiliate but we have to remain realist: all FQE members are *not* going to switch to the new Provincial Association. Because separatists will usually refrain from buying a CFC membership, the new Association will remain small compared to other Affiliates of the CFC. The FQE, as long as it exists<sup>13</sup>, will try to hinder our activities, even though such an action is contrary to its Constitution<sup>14</sup>.

The Chess players in Quebec lives mostly in Montreal or around Montreal. No Quebec Open organised outside of Montreal has ever been successful compared to those organised in Quebec's largest city. Furthermore, most of the elite players live in Montreal. For those reasons, the support of the Montreal Chess League is essential for the establishment of any new Provincial Association. *The MCL AGM has unanimously approved the creation of a new Provincial Association* and the League is ready to assume the role of one of the founding members.

How can the new Provincial Association survive when the FQE receive a large subvention? By not pretending to be a national Federation! The FQE has always acted as if it were a real national federation and as such has to support a lot of duplicated cost for its own independent arbiters, trainers and organisers certification programs; other duplications occurs for the publication of its own review rather then contributing French articles to CCE, FQE rating require an employee for data entry, edition of its own Official Rules of Chess<sup>15</sup> and official Chess Course for beginner has resulted in thousands of dollars of immobilised assets. In fact, according to old members, the FQE was doing better before it got its subvention. The FQE did survive for almost two decades without any subvention.

The persons behind this project are the same that have brought to Montreal several National Championships during the last five years. They are committed toward the CFC.

It is shameful to have no Affiliate in the largest province of Canada. Lets act now to correct this harmful situation!

CFC Interim Office Report – up to January 1, 2006

Overall, we're doing better financially than last year at this point in time, in spite of the continuing decline in adult membership. Aren't people interested in reading the magazine anymore?

#### 1. Membership

Over the past 8 months, our adult membership has gone down another 86 members, to 1402.

It has gone up a little during the big summer events but since then has fallen. It's discouraging to see how many people are giving up on the CFC. There seem to be several tournament members – in fact, there is usually a 3 to 1 ratio of tournament members to regular adult and junior renewals. As well, tournament membership fees are down by 40%. This amounts to a loss of \$4000 income, but the real problem is the lack of interest in the magazine and playing CFC tournament chess.

But every cloud has a silver lining. Five people became CFC Life members during this period. There were only two from all last year (fiscal year).

#### 2. Inventory Sales

Despite poor membership numbers, sales have gone up from last year. So far, we are \$8000 ahead of last year. Yes, last year showed a continual slide so hopefully we've bottomed out.

Unlike last year, the CFC setup shop at the Northern Ontario Youth Chess Championship and made over \$8000 worth of sales. As well, sales from the Canadian Open came to about \$12,000, considerable more than the previous year. And I haven't added in the sales from the CYCC Agincourt regional (why don't more people hold CYCC regional tournaments?) The key is to setup shop in as many tournaments as possible, making sure the store has plenty of goods, and stays open to give players easy access while the tournament is running.

NOTE: When tournaments advertise that the store will be setup at the site, it attracts more players (there were 140 kids at the CYCC Agincourt regional).

#### 3. Shipping

People have been complaining about the cost of shipping, but the fact is, our costs are low – so low in fact that we're actually losing money overall. We charge a minimum \$3, and often less than \$5 to ship a small package. Shipping costs continue to go up. On average, a small package will cost \$7 to ship in Ontario, \$8-\$9 to Alberta or BC,

and \$13 to rural areas. This is another reason to setup shop around the country for major tournaments.

#### 4. Donations

In May of 2005, there was a Canadian Revenue Agency audit for 2002-2003 and 2003-2004 fiscal years. They were concerned about certain donations being made, especially donations made by parents of children who were participating in the WYCC. Brian Watson has also questioned this practice. We are still awaiting the audit results.

Most of the donations on record are again for the WYCC program (almost \$88 000). But expenses for the WYCC will be over \$110,000 once we get the FIDE bill. Much of these charges do not show on the income sheet because most was paid with money collected for the 2005 CYCC program. As well, we are still waiting for some reluctant parents to pay the remainder of their WYCC fees.

Other donations include Nathan Divinsky who donated his time and money to go to the FIDE congress (over \$4000). These costs can be seen under Other Int. Expenses.

And remarkably, we've received over \$60 000 in donations toward the Olympic program.

As well, Team Chess Inc. has been formed to look after and train our team. So it looks like the \$20 000 Olympic expenses budgeted will be covered nicely.

#### 5. Office Report

So far this year, we've installed two new computers, high-speed internet and Quickbooks software for doing financial reports. Eventually, the CFC program which was used for everything will be phased out altogether. Quickbooks is now being used to do all sales, purchases and handling all other financial matters. A new program is being developed to handle the ratings and membership database, and website.

At the most recent AGM for our condo corporation, it was decided that everyone be assessed a considerable amount of money to fix up the property. The buildings are older now and the previous property management team did not do its job keeping up with repairs. The roofs all need to be replaced. Some buildings have exterior walls with leaks, sidewalk is deteriorating, etc. As well, the previous property management group could not keep the financial books in proper order and they did not have our best interests in mind. So we sought a new property management group.

With the special assessment, we will have to pay \$12,667.29 over the next nine months. But this will increase the value of our property and make it easier to sell in the future. I contacted Brian Watson, our accountant, and he is investigating how best to treat this expense.

#### 6. CYCC and WYCC 2005

At years end (April 30, 2005), we had collected \$23,143.98. But these totals were spent as follows

Then we received the FIDE bill in January. \$4,000 needs to go towards the WYCC registrations, so that will take away the remaining \$1636 and impact Other International Expenses. This will be reflected on the January statements.

#### 7. Assets

At present, we have \$78 000 worth of cash and money in the bank. But when you deduct \$1200 for the Canadian Junior Fund, \$1713 for Pugi Fund, \$60000 in Olympic donations, about \$2000 current provincial and affiliate rebates (due January 31), we don't have much money to throw around. The January FIDE bill has been paid, but it cost over \$7000. We have about \$13000 left but when you consider the special assessment mentioned above, you'll see that we MUST be very careful with our expenses for the next while.

Many schools have ordered school supplies and we expect about \$3000-\$4000 worth of sales coming in the next two weeks.
