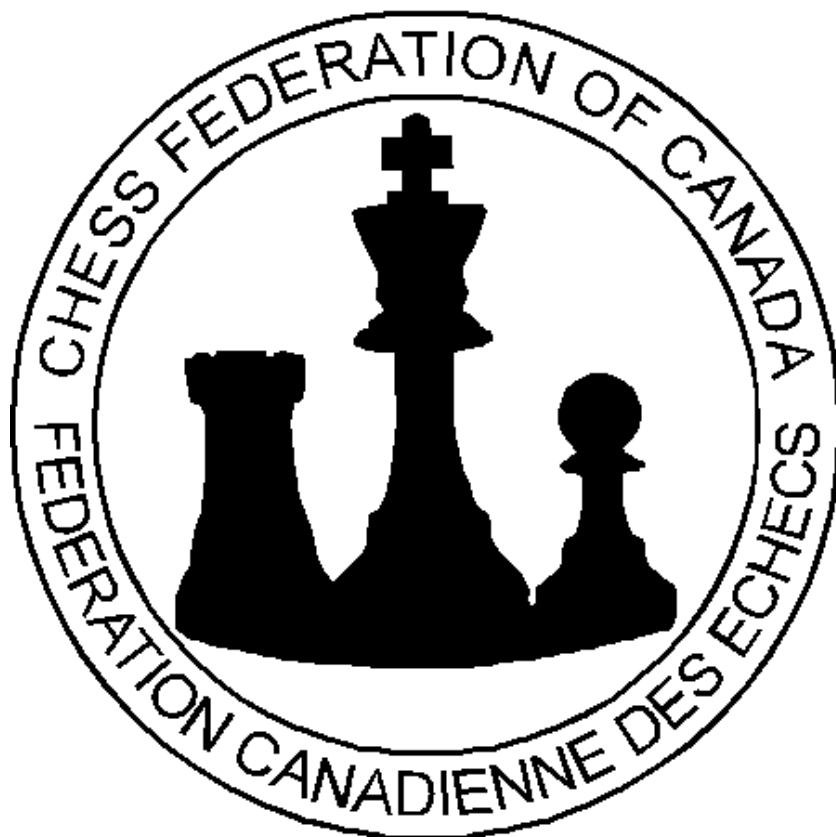

## President's Message

Last year this Executive took office with certain specific goals in mind. We have come a long way to realizing all aspects of our agenda. The CFC will have an operating surplus for the first time in many, many years. I have attached an operating budget for fiscal 2010. Some aspects of the agenda were obvious, and others were proved to be unexpected yet fortuitous

After prolonged negotiations it became apparent that it would not be possible to agree to the terms proposed by the acting Executive Director. The Executive voted unanimously to accept an unsolicited proposal from Gerry Litchfield and Patrick Smale to take over the management of the CFC office as the new Executive Director. This proposal was both more financially prudent and more ambitious than anything else we had considered and is a key reason that the CFC is finally on a secure financial footing.

The CFC has established an on-line magazine to replace the print magazine. However, the webzine is not yet where we need it to be. We had retained a number of Canada's top players as regular contributors but the weekly columns were not implemented. Hopefully this will be a priority for the new Executive Director.

There has been considerable discussion over the years regarding Governor participation. Like many, I assumed that there were too many Governors and now there is a motion on the floor to reduce the number of governors. However, I have to ask, what specific problem does reducing the number of Governors solve? Have there been motions that failed due to a lack of quorum? Have motions failed to pass simply because not enough people voted? While the optics of half the Governors not voting is bad, we should remember that in time of crisis the vast majority of Governors have stepped up and voted. On the other hand, there is a real risk in reducing the number of Governors too much. By minimizing voices, we run the risk of having a very small group of unelected Governors essentially running the organization with no mechanism for change. Fundamentally, reducing the number of Governors is undemocratic and does not solve any problem other than one of optics.

I have tabled a number of motions in this GL for vote at the annual meeting. I think that it is very important for the job descriptions of the Executive to reflect the objectives of the organization. Currently, no member of the Executive is responsible for our major championships. We need Executives who understand their responsibilities and who are ready to fulfil them.

The last Governors' Letter before an Annual General Meeting has always been a time where the outgoing executive reflect on the moves made in the last year. This year has been more difficult than most.

This has been a momentous year in the Federation where the board has had to face some very tough medicine in the form of the sale of the Business Office building and a large-scale restructuring of our finances. While negotiations were under way it was not possible to publicize all our steps as that would weaken our negotiation position but it is our hope that the Governors will approve what we have done.

It's fair to say that this year's board was NOT happy to be taking the strong steps we had to take but it was clear that 3 or 4 more years under the present setup was a recipe for insolvency and the alternative was winding up the Federation which no one wanted. For myself, I say that many of the decisions we took gave me no pleasure but were done to put the Federation on a far more stable foundation.

We have indeed lived in "interesting times" this year and I speak for the Directors in saying that we hope we have left the 2009/10 board a much cleaner road to follow that we have had in the last year.

I will be a candidate for Secretary in 2009/10 and hope to be back to serve you again. If this is not to be then I'd like to express my thanks for having had the opportunity to serve the game I love.

### **Youth Coordinator Report**

The organizers of the CYCC and Canadian Junior are doing a great job advertising the tournaments.

As of June 11<sup>th</sup> there were 113 players registered for the CYCC, so is on track to have between 120 and 150 players. They arranged some bursaries to cover part of the accommodation costs for eligible players from various provinces to attend the Canadian Junior. They would love to welcome players from the Maritimes who are not currently registered.

This year's WYCC will be held in Kemer Turkey (same as in 2007) from Nov 11<sup>th</sup> to Nov 23<sup>rd</sup>.

It was an interesting year. I learned to appreciate the qualities of my colleagues on the Executive committee. This is a volunteer organization and I believe the executive and the Governors have the best interest of the CFC at heart.

## **MOTIONS FOR FINAL VOTE:**

### ***Motion 2009-10 (Moved / Seconded Hal Bond / David Lavin)***

Any player from Canada who applies for a FIDE player title must have maintained a CFC rating, for at least 15 games, which is not more than 100 points below the FIDE benchmark for the title/norm in question.

**Hal Bond:** The CFC has no regulations which guard against player titles being earned under questionable circumstances, or titles which can be earned at our Zonal Championships. The intent of this motion is to provide some modest criteria for such cases.

At the Dresden Congress a Canadian player's IM title application came under scrutiny. With a CFC rating of 2266 and a FIDE rating of 2229, the individual travelled to Eastern Europe in 2005 and 2006, where he scored 3 IM norms and added 180 points to his FIDE rating. He then returned in 2008 to this same region where he held his FIDE rating over 2400 in 3 more tournaments. He has not played in Canada since 2004

### **Motion # 2009-11**: Moved: Kerry Liles; Seconded: Michael von Keitz

- that section 5 of CFC Bylaw 1. dealing with " Ordinary Membership ", Section 2 of the CFC Handbook, is amended by adding after the words " the assembly of governors ", the following:

-

" ( see CFC Rules and Regulations, Article 1, Section 9 ) ".

Commentary: The new section 5 as amended will read:

#### CFC Bylaw 1

### **ORDINARY MEMBERSHIP**

5. Any person, ordinarily resident in Canada , may become an Ordinary Member of the Federation, for the then-current fiscal year, upon payment of the Membership per Capita Fee, directly to the Federation, or through his Provincial Organization. Every Ordinary or Life Member has a right to vote on the appointment or election of the Governor or Governors who will represent his Provincial Organization. Every Ordinary or Life Member has a right to vote on the appointment or election of the Governor or Governors who will represent his Provincial Organization at the assembly of Governors ( **see CFC Rules and Regulations, Article 1, Section 9** ), but shall not be entitled to vote under any other circumstances unless specifically provided in these by-laws.

This amendment, referring to section 9 of Article 1 of the CFC Rules and Regulations, is necessary to have this section not conflict with the new amended section 9. Currently the old section requires that each CFC member is allowed to vote for ALL provincial CFC Governors for that province. This amendment makes it clear that a province will be able to restrict its CFC members to only voting for CFC governors for their provincial region, if the province is so divided.

Note that this amendment is considered a constitutional amendment under Bylaw # 3 of the CFC, section 3, which is:

## BY-LAW NUMBER THREE OF THE CHESS FEDERATION OF CANADA

### ANNUAL MEETING AND AMENDMENTS TO THE CONSTITUTION

1. ....

2. All matters to be decided by the Assembly, shall be decided by a majority vote, save as hereinafter provided.

3. Any amendment or revision **of these By-Laws**; any matter pertaining to any international agreement between the Federation and any international or foreign Chess Federation or Association; and any matter pertaining to the payment of dues to the Fédération Internationale des Echecs may be made,

(a) **at any Annual Meeting** of the Assembly, providing that a notice of intention to submit such matter to a vote has been received by the Secretary at least 30 days prior to the date of such Annual Meeting and has been transmitted by the Secretary to each Governor at least 14 days prior to the date of such Annual Meeting and that any resolution pertaining to such matter shall be **approved by at least a two-thirds majority of the votes of those present and entitled to vote, including proxy votes.**

(b) **at any time through a mail vote** of Assembly, providing that the exact wording of such proposed amendments or revision, or of the resolution to be passed by the Board through mail vote is submitted to each Governor at least fourteen days before the expiry of the time limit specified by the President for the receipt of the votes by the Secretary, and that **at least one-half of the number of votes eligible to be cast has been received by the Secretary, and there is a majority of at least two-thirds of the votes cast in favour** of the proposed amendment or revision or resolution.

**Motion # 2009-12:** Moved: Kerry Liles; seconded: Michael von Keitz;

- that section 9 of the Article 1 of the CFC Rules and Regulations, section 2 of the CFC Handbook, is amended by adding at the end the sentence:

“ However, should the Provincial Organization see fit, it can devolve the holding of meetings to regional affiliates, and restrict the Federation Members to voting only for the CFC Governors allocated to that particular region. “

Commentary: The new section 9 as amended will read:

CFC Rules and Regulations, Article 1

### SELECTION OF GOVERNORS BY PROVINCIAL ORGANIZATION

9. As soon as possible after the receipt by a Provincial Organization of the aforementioned Certificate, such body will convene a meeting of its Federation Members for the purpose of electing its necessary number of nominees for the Board for the ensuing term. **However, should the Provincial Organization see fit, it can devolve the holding of meetings to regional affiliates, and restrict the Federation Members to voting only for the CFC Governors allocated to that particular region.**

Each CFC member has the unrestricted right to vote for ALL CFC Governors for that Province. That is the interpretation given to the CFC Handbook sections by CFC and by the provinces of B.C., N.S., and N.B ( We are not aware of the interpretation of other provinces )..

*(Lyle Craver: As well as being national Secretary, I am BC provincial Secretary/Treasurer and am unfamiliar with BC ever having endorsed this interpretation – ed.)*

But what is appropriate for provinces with fewer members, is not appropriate for a large province like Ontario which has many CFC members spread throughout the province. To make the system of CFC Governor election more effective, Ontario has used the concept of localizing the election of CFC Governors into geographic regions. CFC Members often do not know those standing for Governors in other regions, and their vote in that regard would be uninformed. But each member can know those running for governorship in their own region of the Province. So it is beneficial for a CFC

member in Ontario to have his vote RESTRICTED to those CFC Governors from his own region. And this system could be applicable to any other province/territory, if they wished to regionalize as well.

The problem is that the CFC Handbook as currently written does not give the Provincial Organizations the power to restrict the CFC member governor vote in this way. An amendment of the CFC Handbook is therefore required for this.

The amendments will then legitimize the current Ontario CFC Governor election system. And it will make such a system available to any other province/territory interested in such a regime.

#### **Motion 2009-13 Re: CYCC Qualifiers**

(Ellen Nadeau / David Lavin)

The motion to replace the Articles 1003, 1004, 1005, 1006 of the CFC handbook is as follows:

Will participate in the CYCC 2010 and subsequent CYCCs, only:

-the qualifiers from that years YCCs

-the qualifiers from the CYCC to the WYCC of the previous year

-the highest rating of each age category (open and female) of each province(as of May 1st prior to the CYCC) .

The proof of qualification will rest with the applicants to the CYCC

Discussion: See Junior Coordinator's report above

*Ellen Nadeau:* I am surprised that there were no comments sent to the Secretary for inclusion of this GL.

Please note that a YCC tournament must be 'sanctioned' by the CFC to be considered a YCC qualifier event for the CYCC. Organizers must be contact the Youth Coordinator to arrange payment and...

**Motion 2009-14:** Moved: Governor Patrick McDonald; Seconded: Governor Paul Leblanc

**Numbers of Governors for Each Province:** this subsection of section 1 of By-law # 2, shall be amended by deleting in both places the word “ fifty “ and substituting for it the words “ one hundred “.

#### **Commentary:**

The current subsection of section 1 of By-law # 2 dealing with “Numbers of Governors for Each Province” is:

### **Provincial/Territorial Governors: BY-LAW NUMBER TWO OF THE CHESS FEDERATION OF CANADA**

#### **1. ASSEMBLY OF GOVERNORS**

#### **.... NUMBERS OF GOVERNORS FOR EACH PROVINCE**

Each provincial association shall be entitled to elect or appoint a number of Governors as follows:

For the first fifty or part thereof of ordinary per capita fee payments, and number of life memberships combined, one Governor shall be allotted and for each subsequent fifty or part thereof one additional governor shall be allotted.

By this motion, the number of Provincial/Territorial Governors shall roughly be reduced by 50%. This would mean that the number of governors for a province/territory will be one for every 100 members (or part thereof), instead of 50 members. We set out below a rough estimate of what that would mean, based on the number of 2008-9 Governors:

Our first concern is “administrative”. There are 61 governors for about 1400 adult members. This works out to about a governor for every 23 adult members. Where do you get these kinds of representation figures in real life organizations?? This is bureaucratic overkill. And it makes decision-making difficult when there are so many voters to communicate with and get to vote. Getting quorums becomes a problem with such a large body of deciders. It makes constitutional amendments outside of the AGM almost impossible. Today’s business models tend to be lean and mean – smaller groups that can make decisions quickly – our system is cumbersome to say the least. Surely the system needs at least to be somewhat leaner.

Reducing provincial governor representation by half would greatly assist decision-making by the CFC. A smaller decision-making body in this aspect would help streamline the organization and make decision-making much more effective.

Our second concern is “qualitative” - that over the years, we have seen exceptionally low participation by governors in voting, and in participating in CFC affairs in various ways. For example, CFC motion 2009-06, voted on by e-mail in December 2008, had only 15 governors voting out of a total of 61 – this is an abysmal participation rate of 25% ! Motions 2009 -5, 7, and 8 did a bit better, with an average of 28 governors voting, but even then we are still at a less than 50% participation rate ( only 46 % ). We feel that this impairs the effectiveness of the organization, and demoralizes those who do participate.

One of the problems is that the provincial associations have trouble recruiting sufficient good candidates for the high number of current governor positions. Simply put, there are not enough good people to go around. Consequently, in an attempt to fill the seats, the provinces drag members in who have little commitment to working for the organization, though they may agree to have their names put forward, to be cooperative. But they have no intention of participating. If the number of positions was reduced by 50%, the provinces would have a chance of filling the lower number of places with good candidates.

Our governor structure has great merit – it is democratic and representative. But decision-making needs to be streamlined.

[Editorial Note: the mover and seconder have requested that this be considered a Constitutional Amendment as discussed in Bylaw # 3 of the CFC, section 3, which Governors can review at [http://www.chess.ca/section\\_2.htm](http://www.chess.ca/section_2.htm) - I fully support this request – ed.]

### **Motion 2009-15** Moved David Lavin/Maurice Smith

Moved to amend By-law Number three of the Chess Federation of Canada, the section “Duties of Officers” to read:

#### **President**

The President has the full power to make any and all decisions on any matter that is not explicitly the responsibility of the Assembly of Governors and/or The Board of Directors (aka – The Executive). In matters where an immediate decision is not required the President will confer with other members of The Board of Directors. The President must present a budget for the new fiscal year to The Assembly of Governors at least 30 days prior to the start of the new fiscal year. This budget must indicate a surplus for to upcoming fiscal year.

The President will make best efforts to ensure that the annual budget is adhered to by the Executive Director.



**Vice President**

The Vice-President will take on the duties and title of President if and when the President becomes unwilling or unable to discharge his/her duties.

The Vice-President will manage the CFC's relationship with FIDE, including submitting title requests on behalf of Canadians who have qualified for various titles.

**Secretary**

The Secretary will be responsible for the safekeeping of all books, records, correspondence and other documents pertaining to the affairs of the CFC.

The Secretary will be responsible for the minutes of the AGM and any and all Executive Meetings.

The Secretary will be responsible for the distribution to the governors of all motions, and for the tabulation of the voting results for all motions.

**Treasurer**

The Treasurer will be responsible for reviewing the financial statements as produced by the Executive Director and for producing audited statements if requested by The Executive. The Treasurer will also be responsible for developing, in conjunction with the President, an annual budget at least 30 days prior to the fiscal year-end.

**Tournament Coordinator**

The Tournament Coordinator will help to develop and train tournament organizers and directors across the country.

The Tournament Coordinator will be responsible for soliciting individuals to bid on and organize major tournaments in Canada, including, but not limited to:

The Canadian Open Championship The Men's and Women's Olympic Teams The Canadian Closed Championship

**Junior Coordinator**

The Junior Coordinator will be responsible for coordinating our participation in the WYCC and for finding organizers for:

The Canadian Junior Championship Youth Chess Championship, Canadian Youth Chess Championship

**External Coordinator**

The EC will be responsible for promoting the image of the CFC and as such will work with chess clubs across Canada to raise the profile of the CFC; work with the editor of the webzine to develop content that is club specific work with the editor and celebrity chess commentators to develop paid content that raises the profile of the webzine and the CFC

## **Appendix 2: Year-End Report Chess Foundation of Canada**

31 May 2009

### CHESS FOUNDATION OF CANADA 2008/2009 TREASURER'S REPORT

1. A financial statement for the year ending 30 April 2009 is enclosed.
2. Assets on hand total \$161,397 and are invested as itemized in the financial statement. This total includes the Pugi Memorial Fund balance of \$20,504.
3. The Foundation Trustees approved a further \$18,500 emergency loan to the Chess Federation of Canada during this period. This loan and the preceeding loan of \$30,000 were repaid in full in February 2009. Once the loan was repaid, the 2007/2008 annual disbursement from the Foundation to the CFC (\$5682) was submitted to the CFC.
4. Investment income for 2008/2009 was somewhat less than 2007/2008 for two reasons:
  - a. funds invested were less due to the \$48,500 interest free loan to the CFC; and
  - b. market Interest rates on fixed income investments have declined.
5. The Foundation's investments have been diversified somewhat. Fifteen percent of assets have been invested in preferred shares carrying an average dividend yield of 6% and 15% of assets have been invested in an exchange traded fund comprising the 60 largest publicly traded Canadian companies. This small equity investment will provide some growth to the Foundation's assets and currently yields 3.5%.
6. A cheque for \$4,384 will be forwarded to the CFC of which \$760 is specified for the Pugi Fund to assist promising junior players.
